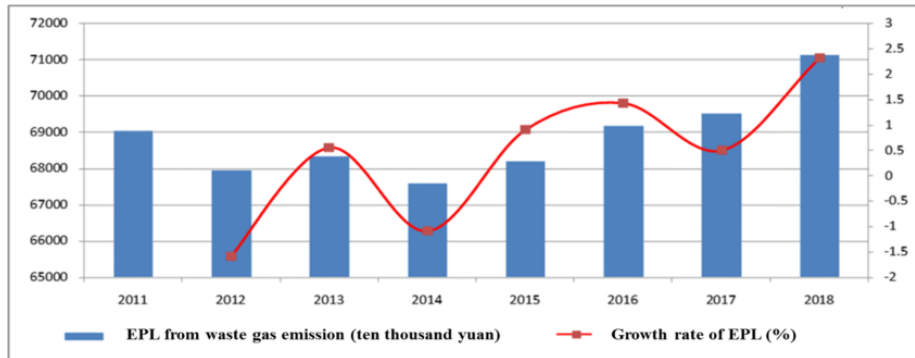


Fig. 1. A figure caption is always placed below the illustration. Short captions are centered, while long ones are justified.
